Center for New Media and the Arts presents the group thematic exhibition, *Figure Reprisal*. This exhibition will be held at the the Center for New Media and the Arts from August 6<sup>th</sup> – September 2<sup>nd</sup>, 2010.

*Figure Reprisal* is open for entry to all artists working in any media. All interpretations of the theme, including such genres as graffiti, pop, comic book, illustration and pop surrealist, will be reviewed and considered.

**ELIGIBILITY:** *Figure Reprisal* is open to all artists, national and international, working in any media. Entrants must be 18 years of age or older to apply.

**IMAGE PRESENTATION OPTIONS:** Artwork must be submitted digitally either by mailing a CD to

**DIGITAL FILES ON CD:** Digital files with prints may be submitted on CD, DVD or Zip discs. Image files should be readable on Mac systems and should be in TIF or JPG format. Maximum file size is 15 megabytes. Submit only *one* image per artwork.

**EMAIL ENTRY:** This form is designed to be printed and mailed. To submit via email, submit the information required on the entry form below (name, address, etc.) as the text of an email message. Send your images attached to the email individually or as a single zip file. Files sent via email should be in JPG format, 300dpi. Submit only *one* image per artwork. Pay the entry fee via PayPal on the Center website ([www.cnmabethel.com](http://www.cnmabethel.com)) at the time of submission.

**RETURN OF MATERIALS:** A self-addressed-stamped-envelope (SASE) must be included with sufficient postage for the return of your submission materials. Artists outside the U.S. may include international reply coupons instead of stamps, or may add return postage cost to their entry fee at a rate of \$1.20US per ounce of mail. If you do not want your materials returned, but want mail notification, include a stamped #10 letter size envelope for a notification letter.

**NOTIFICATION:** Artists will be notified of acceptance or non-acceptance no later than June 30th, 2010. Notifications will be made by mail using the SASE provided by the artist. Notifications will also be sent via email.

**ENTRY FEE:** There is a \$20.00 entry fee for 1- 4 works (1 image per work). If you wish to submit more than 4 pieces, please include \$5.00 for each additional. Artists accepted to exhibit will not be charged additional fees of any kind. **Please make check or money order payable to CNMA.**

**CREDIT CARD:** Entry fee payments may be online with PayPal through the Center website ([www.cnmabethel.com](http://www.cnmabethel.com)). Go to the Opportunities page, and click on the Figure Reprisal Entry Fee link. With mail entries, print the transaction confirmation page and mail it with your entry materials.

**AWARDS:** 1<sup>st</sup> Prize \$500 2<sup>nd</sup> Prize \$100

**TERMS:** All works in the show must be for sale. The gallery will take a 50% commission on all sales. Sale price determined by artist.

**DEADLINE:** The *final* postmarked deadline is May 15th, 2010. Entries must be postmarked by this date.
